Women's Issues in Maryland: A Look Ahead to the Maryland Legislative Session

Senator Susan Lee, District 16, Maryland

Susan C. Lee represents District 16, which includes Bethesda, Chevy Chase, Friendship Heights, Potomac, Rockville, Cabin John, and Glen Echo. She was elected to the Maryland House of



Delegates in 2002 and to the Senate in 2014 to represent District 16 and has been described as the General Assembly's leader on cyber security and innovation, identity theft, online fraud, and consumer protection issues. Maryland's strongest advocate for women's issues of concern to AAUW, Susan led efforts to pass an aggressive agenda of legislation to fight domestic violence, sexual assault, and human trafficking; economically empower women, children and families; secure funding for statewide rape crisis centers; and authorize the placing a statue of Marylander and American hero Harriet Tubman in the United States Capitol. Susan also is a champion of education, the environment, public safety, civil rights,

transportation, quality health care, telemedicine, bioscience, clean energy, and emerging technologies.

President's Letter

Dear Friends,

As I write this, I have just sent off my holiday cards and am getting into the mood of the season. I was reflecting on the recent mid-term elections and am delighted that a record number of women – from both parties – were elected to House and Senate seats. The coming

year will be challenging to those of us who value and fight for women's rights, but there are positive signs that we have strong voices among our elected officials who will care about reproductive rights, marriage equality, violence against women and other issues key to women and to AAUW. I hope that each of you will be one of those voices.

At our November meeting, we learned about one issue on which some of you may wish to take an active role. Donna Smith, Maryland campaign director for

Compassion & Choices, outlined the bill to be introduced in the coming Maryland legislative session. The Medical Aid in Dying will legalize efforts for people to have the right to participate in their own end of life choices. She shared plans for introduction of legislation in the 2023 Maryland legislative session.

Medical Aid in Dying is a trusted and time-tested medical practice that allows a terminally ill, mentally capable adult with a prognosis of six months or less to live to request from their doctor a prescription for medication they can decide to self-ingest to die peacefully in their sleep. Eleven states, including Oregon, the model for the Maryland bill, authorize medical aid in dying.

There are other bills upcoming in the legislature which also need our support. Carol Starr, Vice President for Public Policy for our Bethesda-Chevy Chase AAUW branch, will share our priorities at the January meeting. Maryland AAUW is part of MLAW, the Maryland Legislative Agenda for Women, a coalition of women's groups in Maryland which actively organizes support for those bills which member organizations have selected as most important to women.

Prior to serving in the Senate, Frosh also represented District 16 in the Maryland House of Delegates, serving two four-year terms His most recent service was as Maryland Attorney General from 2015 until January 2023.

Save the Date/Event Alert - Artists 4 ERA!

Three Maryland branches have come together to organize a fundraising event that will raise money for the effort to finally get the ratified Equal Rights Amendment enshrined into law as the 28th Amendment to the Constitution. They are working through VoteEquality.org, a national organization whose mission is to advocate for the ERA to be certified by the National Archivist. This would be the last step in solidifying gender equality as law across the United States.

The Baltimore, Howard and Anne Arundel branches successfully applied for a 'mini grant' which will be used to set up an exhibit of ERA-related posters in Catonsville, MD in late February/early March 2023.

Artists 4 ERA will be a unique event with posters by well-known artists, including one by Shepard Fairey, who created President Obama's "HOPE" poster. These works of art visually heighten awareness of the need to finalize the ERA. The signed posters will be sold through a silent auction and a raffle to raise money to advocate for the ERA. All of the posters can be seen at Artists4ERA.org. As stated on their website:

"Through partnerships with well-known artists, this depicts diverse groups and communities, including LGBTQIA+, Black women, women of color, Indigenous peoples, and young people, to help them see themselves in the struggle for equal rights in the Constitution. The art created for the project will financially support VoteEquality's work to ensure gender equality is part of our Constitution through and live releases of limited edition, signed ERA art prints."
