# What is the Role of Religion in the National Dialogue in the Trump Administration?

## **David Gray**

In the new Trump administration, the role of religion in approaching national issues, Supreme Court decisions, and voting patterns has increased. Issues of separation of



church and state are being challenged by some – particularly conservative – religious groups. David Gray, senior pastor of Bradley Hills Presbyterian Church in Bethesda, heads a congregation committed to interfaith concerns. Bradley Hills is a unique space that houses three faith traditions. In 1967, Bethesda Jewish Congregation (BJC) joined the BHPC campus. In 2019, they welcomed Maqaame Ibrahim Islamic Center (MIIC). Each November they hold a well-attended interfaith service where members of our three faiths worship together. Before his call to ministry, he worked in business and law and continues to serve on forprofit and non-profit boards. David is a former scholar, program director, and senior



fellow at the New America Foundation think tank. His articles have appeared in a variety of religious and secular publications and as assignments in courses. David's books include, *Practicing Balance: How Congregations Can Promote Harmony in Work and Life; The Five Letters Every Christian Should Write; Christian Followship: Discipleship and the* 

Gospel of John for the Post-Pandemic World; Blessed Benedictions: Sending Them Home with a Good Word; Faith in Service; 1015; and Spiritual Calcium. He has enjoyed the privilege of speaking and preaching in a variety of contexts nationally. David is a former Acting Assistant Secretary for policy at the U.S. Department of Labor (DOL), where he managed a 54-person team and the DOL offices of regulatory policy, programmatic policy, compliance assistance/technology, and economic analysis/research. He staffed and was principal in several White House working groups and represented the U.S. abroad in negotiations in Mexico and Chile. He has served as a counsel to the U.S. Senate Subcommittee on Government Management and Senate Governmental Affairs Committee and as a legislative aid to several members of Congress.

He has been a term member of the Council on Foreign Relations, was a founding board member of the Journal of Inter-Religious Studies and is a college fellow at Yale University. David received a bachelor's degree in history from Yale University, a master's degree in public administration from Harvard University, with a focus on non-profit management, a juris doctor from Northwestern University School of Law, and both a master of divinity with honors and a doctor of ministry in church leadership from Wesley Theological Seminary.

### **National and International Perspectives on Early Trump Initiatives**

#### **Mark Medish**

The Trump Administration has advocated for significantly different national and international policy decisions from previous administrations. In the recent national election, his views were in stark



contrast to those of the other Presidential candidate. Mark Medish will share his insights into how US policies throughout the world and current US politics are changing under the Trump Administration – and the implications of those changes. Actions of the Supreme Court and legislative elections also have profound implications for the US and the international community. He has a unique view on US foreign policy. Mark Medish, a member of the US National Security Council under President Bill Clinton and a former deputy assistant secretary of the Treasury, is a co-founder of Keep Our Republic, a non-partisan civic organization. He is

also Vice Chair and Director of Panterra.

He served at The White House as Special Assistant to President Bill Clinton and Senior Director for Russian, Ukrainian, and Eurasian Affairs on the National Security Council, 2000-2001. He also served at the U.S. Treasury as Deputy Assistant Secretary for International Affairs under Secretaries Robert Rubin and Lawrence Summers, from 1997 through 2000. He also worked at the State Department and UNDP.

Medish was previously president of Guggenheim International, a division of the diversified financial services firm Guggenheim Partners LLC, with over \$220 billion of assets under management. Prior to joining Guggenheim in 2012, he was Executive Vice President of APCO Worldwide, Inc., a global public affairs firm. Medish worked with the Carnegie Endowment for International Peace, where he served as Vice President for Studies focusing on Eurasia and China. He was a partner at the international law firm Akin, Gump, Strauss, Hauer & Feld LLP, where he led an advisory practice on sovereign debt restructuring and emerging markets investment.

Medish was educated at the Georgetown University School of Foreign Service, Harvard Graduate School, Harvard Law School, and Oxford (Merton College
