### **Looking Forward to the Maryland General Assembly**

#### **Maryland Senator Sara Love, 16th District**

Sara Love was appointed to the Maryland State Senate by Governor Moore in June 2024. She was first elected to the Maryland House of Delegates in 2018, where she served on the Environment & Transportation Committee and two of its subcommittees, the Motor Vehicle & Transportation Subcommittee, which she chaired, and the Environment Subcommittee. She chaired the Land Use, Transportation, and Public Safety Committee for the Montgomery County House Delegation.



Prior to the General Assembly, Sara spent her career working to make the world a better place, focusing mainly on reproductive rights and civil liberties. After graduating from Princeton University, Sara earned her law degree from Northwestern University School of Law.

As a young lawyer she worked on several important cases focusing on equal justice. She worked on a mortgage discrimination case with another young lawyer -Barack Obama. She also worked on a nationwide case against anti-choice extremists who used force, threats and violence to shut down women's health care clinics. From there she became general counsel to nine clinics across the country and worked with federal, state, and local law enforcement to train them on the Freedom of Access to Clinic Entrances Act (FACE). Following her passion for women's rights, she went to NARAL Pro-Choice America and became their General Counsel and Legal Director where she worked on federal reproductive rights policy and led a staff to support affiliates across the country working on state policy.

Sara's work on the ACLU Board led them to ask her to join the staff as their Public Policy Director, where she led their policy and legislative work for four years. During that time, she worked on many issues including reproductive rights, racial justice, public funding for public schools, criminal justice reform, saner drug policies, technology and privacy, the First Amendment, open government and accountability, and voting rights.

Sara spoke with our branch a year ago as we looked forward to the 2025 General Assembly. In this session, she will provide insights into the upcoming 2026 Session.

### **National and International Perspectives on Trump Initiatives**

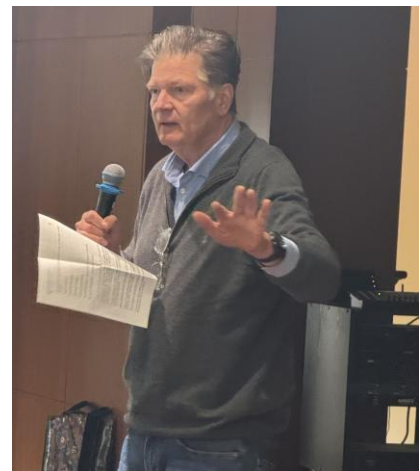
#### **Mark Medish**

Mark Medish will share his insights into how U.S. policies are unfolding under the current Trump Administration and their implications in a changing and challenging geopolitical environment.

Mark Medish served at The White House as a Special Assistant to President Bill Clinton and Senior Director on the National Security Council and at the U.S. Treasury as Deputy Assistant Secretary for International Affairs. Medish also served at the State Department/USAID and UNDP.

Medish currently works as Vice Chair and Director of Panterra, a boutique strategic advisory company headquartered in London. He maintains a small private law practice. Medish is a co-founder of Keep Our Republic, a non-partisan civic organization.

He was previously a law partner at Akin LLP and head of the international division of Guggenheim Partners LLC, an investment fund. Prior to that, Medish was Vice President for Studies at the Carnegie Endowment for International Peace.



Medish was educated at the Georgetown University School of Foreign Service, Harvard Graduate School, Harvard Law School, and Oxford (Merton) where he was a Fulbright Scholar.

### Dismantling the Department of Education – Action needed NOW!

Last week, the Trump administration escalated its effort to dismantle the U.S. Department of Education (ED). On November 18, ED announced six “partnerships” moving the day-to-day work of major K-12 and higher education programs to other agencies, after slashing staff across the Department. This is not routine reorganization. It threatens students’ civil rights and access to opportunity. We need your voice now.

### Write to your members of Congress now to intervene and ensure the Department of Education can fulfill its responsibilities to students.

Why this matters: Congress created the Department of Education to enforce civil rights laws in education, administer federal aid, and ensure equal educational opportunity for all students. When ED is hollowed out and its expertise is scattered across agencies not centered on education:

- students lose a clear place to turn when discrimination happens;
- support programs become harder to reach and harder to hold accountable;

- women and girls, students of color, students with disabilities, LGBTQ+ students, Native students, immigrants, and student parents are hit first and hardest.

AAUW is already taking action:

We released a press statement from CEO Gloria L. Blackwell;

We joined a coalition letter urging Congress to block these transfers; and

We joined disability rights principles affirming that ED must remain independent and fully staffed to enforce IDEA and Section 504.

**Now we need every AAUW member and advocate to lift their voice.**

Urge Congress to block efforts to dismantle the Department of Education’s ability to do its job — advancing gender and racial equity in every classroom and protecting students’ rights. If Congress doesn’t act, students and families will feel the fallout first. Please send your letter today. Thank you for standing with AAUW and defending inclusive, high-quality public education for all students.
